Payment and Refund Policy:

Payment for vending spot(s) and any additional vendor passes **must be made in full by October 11th, 2025**, via cash, check, cashier's check, money order, or electronic payment through the official online registration form; vendors are responsible for any fees or issues arising from electronic payment processing. This is a rain-or-shine event; no refunds will be permitted. **Forms received after October 11th, 2025, will not be accepted.** Event organizers reserve the right, at their sole discretion, to cancel or modify the event due to safety concerns or unforeseen circumstances, with no liability beyond refunding vending fees, and to remove vendors for non-compliance with event rules, without refund. Submission of payment constitutes acceptance of all terms and conditions outlined in this registration form.

Vendors are required to possess and provide a valid Seller's Permit and Business License, and failure to provide copies with registration may result in immediate denial of participation. Confirmation and updates will be sent via email.

Vending Information:

Vendors must supply their own pop-ups (weighed down for safety), tables, and chairs, not exceeding their reserved space as selected. This is an outdoor, rain-or-shine event on an active airstrip with no electricity available; vendors assume all risks associated with the venue.

Vendors may begin setup on November 7th, 2025, upon request or notification, subject to organizer approval, at their own risk; no security is provided overnight. Alternatively, set up on event day, November 8th, 2025, begins at 6:00 AM and must be complete by 9:00 AM, when the event opens to the public; all setup vehicles must exit the gates by 8:30 AM and may not return for teardown until 4:00 PM.

Late arrivals or early breakdowns are prohibited and may result in exclusion from future events, subject to and unless approved by organizer. Vendors are responsible for cleaning their own space during and after the event.

Each vendor shall provide a raffle prize with a business card to be collected at the gate on event day, November 8th, 2025. The event will comply with all local, county, state, and federal laws and regulations.
